Pursuant to Utah Administrative Code R315-320-5, to obtain a waste tire recycler registration number and approval to act as a waste tire recycler, a recycler shall submit the following information on this form with accompanying required documentation and fee payment to the Division of Solid and Hazardous Waste. Registration runs from January 1 to December 31 and must be renewed each year.

Area Served: The Waste Tire Recycling Act in Subsection 19-6-809(3) requires that for a waste tire recycler to be eligible for partial reimbursement under the Act, the recycler must, in cooperation with tire retailers or transporters, must establish a reasonable schedule to remove waste tires, in sufficient quantities to allow for economic transportation, from any municipality in the State. A waste tire recycler must be able to provide information that will support the contention that this requirement has been met. | | | | | |
